dance etc. Studio Policies 2023-2024

Please check each box to indicate you have read each policy.

- ☐ **Dance fees are due the first class of each month.** A late fee of \$10.00 will be added to any fees paid on or after the 11th of the month regardless of weekends, cancellations, holidays, etc. **Tuition is based on a yearly rate divided into 9 equal monthly payments. Therefore, full tuition is due each month. It is expected for ALL students to complete the 2023-24 dance year.**
- ☐ A \$30.00 fee will be charged on any checks returned to us by the bank.
- ☐ Dance Etc. will discontinue classes when any student is more than 30 days late in paying tuition.
- ☐ Any student withdrawing prior to the recital will forfeit their \$40.00 recital fee as a drop out penalty.
- ☐ **Costume fees** will be divided into three (3) payments. **Payment #1 - \$40 per class due by October 5, 2023. Payment #2 - \$40 per class due by November 9, 2023. Payment #3 - Balance of costume (if any) due by December 14, 2023. No refunds for dropped classes.**
Any student withdrawing after November 10 will be responsible for their entire costume balance.
- ☐ **Students missing more than 9 classes per year may be excluded from performing in the recital.**
- ☐ Missed classes or withdrawal will not result in any discount of fees. Please call if your child is sick and cannot attend class.
- ☐ Dance Etc. observes the same holiday schedule as the Lenoir County Schools for Thanksgiving, Christmas and Easter vacations. Dance Etc. will remain open for teacher workdays. Notices will be sent out prior to any other closings.
- ☐ If a teacher is sick, a qualified substitute will teach class.
- ☐ Please call if inclement weather (such as snow or ice) may cancel classes. Announcements of closings will be posted on Facebook and Instagram and DanceEtcStudio.com.
- ☐ All students are expected to participate in class unless there is a written note explaining why they need to observe.
- ☐ **Students are required to wear appropriate dance wear to class with their hair pull up and away from their face. No street clothes are allowed in class. Any student not properly attired may not be allowed to participate in class for that day. This includes t-shirts and jeans.**
- ☐ **Students should bring their own water bottle to each class.**
- ☐ Any continuing discipline problems will result in dismissal.
- ☐ Please pick up your child promptly after his/her class time. Dance Etc. is not a child care provider and is not responsible for any child left unattended after class is over. Parents will assume responsibility for damage to property caused by unattended children.
- ☐ **Dance Etc. will not be liable for any injuries your child may receive due to his/her negligence.**
